

Veethree Marine 4-Year Limited Warranty

Veethree Electronics and Marine LLC, ("Veethree") warrants its products to be free from defects in materials and workmanship for a period of FOUR years from the date of original retail purchase or FIVE years from the date of manufacture if the sales receipt is not available.

The warranty period for Veethree products used commercially or in any rental or other income producing activity is ninety (90) days from the date of original purchase.

Veethree warrants the optional anti-fog coating for TWO years from date of manufacture.

We will provide credit or replacement product without charge for any Veethree product covered by this warranty (or similar in styling if the defective gauge is not available), which is returned (freight prepaid) within the warranty period to the dealer from whom such products were purchased, or to us at the appropriate address. In any such case, Veethree products found to be defective and covered by this warranty will be replaced or repaired at Veethree's discretion, and returned to the customer postage paid.

Veethree's sole responsibility under this warranty is limited to the repair or replacement of product which is, in Veethree's opinion, defective. Veethree is not responsible for charges connected with the removal of such product or reinstallation of replacement or repaired parts.

We will have no obligations under this warranty for any product which:

- has been improperly installed;
- has been used in an installation other than as recommended in our installation or operation instructions or specifications;

- has failed or has been damaged due to an accident or abnormal operation including racing, misuse, or alterations outside our factory;
- has been repaired or modified by entities other than Veethree;
- has been used with other product(s) which, in Veethree's opinion, are incompatible with the Veethree product.

THIS WARRANTY WILL BE THE CUSTOMER'S EXCLUSIVE REMEDY. IN NO EVENT WILL VEETHREE BE LAIBLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY EXPRESSED OR IMPLIED WARRANTY RELATING TO THE PRODUCTS. Some states do not allow limitations on an implied warranty or the exclusion of incidental or consequential damages, so the above exclusions may not apply to you. You may also have other rights which vary from state to state.

If any part of this Limited Warranty is determined to be void or illegal, the remainder shall remain in full force and effect.
